**1. Right to withdraw from the purchase contract**

If you are purchasing as a consumer, you have the right to withdraw from this purchase agreement without giving a reason within 14 days of purchasing the service. The period for withdrawing from the contract expires 14 days from the day you purchased the service. The withdrawal period is preserved if you send a notice of exercise of the right to withdraw from the purchase contract before the withdrawal period expires. If the subject of the purchase contract is the purchase of goods, you can withdraw from the purchase contract even before the expiry of the withdrawal period.

**2. Consequences of withdrawal from the contract**

In case of withdrawal from the purchase contract, we will refund 80% of the payment you made in connection with the conclusion of the purchase contract, especially the purchase price. This does not apply to additional costs, nor to the costs of additional services, if they were the subject of the contract and if their full provision. Payments will be returned to you without undue delay and in any case no later than 14 days from the day on which we receive your notice of withdrawal from this purchase contract. Payment will be made in the same way as you used for your payment, as long as you indicate the IBAN numbers of your bank account did not give consent for payment to your bank account without charging any additional fees.

Payment for the purchased goods will be made to you only after the returned goods have been delivered back to our address or upon presentation of a document evidencing the return of the goods, whichever occurs first.

Send the goods back to us or bring them to the address of the company's registered office without undue delay and in any case no later than 14 days from the day of exercising the right to withdraw from the contract. You bear the direct costs of returning the goods.

Please note that in the event of withdrawal from the purchase contract, you are legally responsible for any reduction in the value of the goods as a result of handling it between the time of delivery and the moment of its return in a manner other than what is necessary to determine the nature, properties and functionality of the goods.
